About the Role

- Lead Demsoc strategic engagement in embedding new participatory forms of governance to raise ambition, commitments, and impact in the cities climate transition journeys.
- Support diverse cities in the design and implementation of different governance arrangements based on the locality and context to activate an inclusive ecosystem for change to support Cities's Climate Neutral ambitions.
- Support different cities to ensure high-quality governance practices are enabled in their transition towards Climate Neutrality, supporting the rest of the team to ensure the success of the project alongside a wider team of city advisers and specialists.

- Experience with applied research on or analysis of just climate transition (or other transition processes) and the public institutions and multi-stakeholder partnership it requires, ideally from a policy perspective.
- Strong understanding in transition governance, urban regeneration and the issues core to the Climate Neutral Transition in Cities
- Demonstrated leadership and delivering results with large scale coalitions, and strong track record in working and facilitating multi-stakeholder interventions in particular with government, research, civil society and private sector.
